Declarations

In this document, the following substitutions will apply:

- The applicant / graduate is herein referred to as "you"
- Aesthetics House Limited, trading as The National School of Aesthetics, is herein referred to as "we"

1. You must pay your reprint fees in full as well as submit a completed application.
2. We will not print your reprint certificate(s) until you pay the associated costs, have met our requirements, and filled out the application form to our satisfaction.
3. We will only print your certificate(s) if we can match your name with the name of the graduate in the graduates' database we hold. If you are not in the database, we will not reissue certificate(s).
4. We print certificates in batches and will attempt to get yours printed at the earliest possible time. We may advise you about approximate timeframes. Usually, we print certificates in June and December.
5. If you have indicated you want your certificate(s) shipped to you, you understand we are not responsible for any damages or loss that may occur once the certificate(s) leaves our possession.
6. You need to supply proof of your identity. This must be a government-issued driver's license, passport or other photographic form of ID. If you are applying in person, bring the original with you. If you are applying remotely, supply a verified copy. A verified photocopy is a photocopy with a statement stating, "I certify this is a true and accurate copy" with a signature from someone who takes an Oaths under the Oaths Act. This includes solicitors, police officers, and Justices of the Peace.
7. We can only print your certificates in the name we have on file as your legal name unless you supply us with proof you have legally changed your name. This must be something from the Department of Internal Affairs, and we need to see the original or have a verified photocopy.
8. We reserve the right to reprint your certificate(s) on the current certificate stock we issue if we are unable to reprint it on the original certificate stock you were issued at your graduation or programme completion.
9. If you are still in possession of your original certificates, you need to return these to us.

Making a false declaration is an offence under the Crimes Act 1961.
